

**STATEMENT OF FACT**

This formal **NOTICE OF DEFAULT** is being sent in response to STATE OF CALIFORNIA, FRANCHISE TAX BOARD Notice 4966 dated 04/22/16 and received on 4/28/26. Said notice is entitled **Final Notice Before Levy and Lien** and is not signed under penalty of perjury nor is it signed by a live man or woman with the authority to issue such a notice.

In response to repeated fraudulent notices claiming that Petitioner owed various amounts. The information in the notices was fraudulent, possibly based upon fraudulent substitution for returns issued by the INTERNAL REVENUE SERVICE which are against the law. These computer-generated notices were not signed under penalty of perjury nor signed by anyone from the FRANCHISE TAX BOARD. These notices were in violation of law and Petitioner responded in

a timely manner refuting each and everyone.
