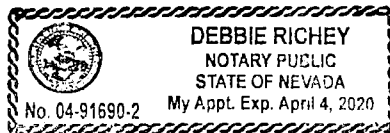

24 After considering all of the evidence, the Master hereby makes the following Findings and
25 Recommendations:

26 The Obligor was properly served on MAY 31, 2016, with a Notice and Finding of Financial
27 and Parental Responsibility.

Obligee has named Obligor, JESSE CHANCE JOHNSON, as the father of AMANDA CAREY, born MAY 17, 2008.

Obligor was properly served and noticed of today's hearing at his/her last known address and failed to appear.

RECOMMENDED ORDER IS:

1. The Obligor is the parent of the following child:

<u>NAME</u>	<u>D.O.B.</u>
<u>AMANDA CAREY</u>	<u>MAY 17, 2008</u>

2. That said child's birth certificate be amended by entering the name of JESSE CHANCE JOHNSON as the father of said child and that the Court order the state registrar of vital statistics to prepare an amended certificate of birth consistent with this order.

3. An arrears Judgment is entered in the amount of \$1,837.00 for October 1, 2015 through September 30, 2016.

To be paid by payments of \$100.00 per month beginning OCTOBER 1, 2016.

All payments MUST be made in the form of a money order, cashier's check or business check and payable to **STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)** and sent to:

**STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)

LAS VEGAS, NV 89193-89501**

The following information must be included with each payment:

- A. Name (first, middle, last) of person responsible for paying child support.
- B. Social Security Number of person responsible for paying child support.
- C. Child support case number 370-84-4000B listed on each payment.
- D. Name of custodian (first and last name of person receiving child support).

PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING OF GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE WILL NOT FULFILL THE OBLIGATION. NOTICE: NO CREDIT WILL BE GIVEN FOR PAYMENTS PAID DIRECTLY TO THE OBLIGEE.

1 4. All payments shall be made by immediate income withholding. If your full obligation
2 is not met by the amount withheld by your employer, you are responsible to pay the
3 difference between your court ordered obligation and the amount withheld by your
4 employer directly to the STATE COLLECTION AND DISBURSEMENT UNIT
5 (SCaDU). If you fail to do so you will be subject to the assessment of penalties and
6 interest. You may avoid these additional costs by making your current child support
7 payments each month.

8 5. The Obligor shall keep the Division of Welfare and Supportive Services informed of
9 any change regarding current residential and/or mailing address, employment and of
10 access to health insurance coverage in **WRITING** (including health insurance policy
11 information) within 10 days of such change.

12 6. Obligor shall be responsible for ALL child support and judgment payments due.
13 Payment is to be made directly to the STATE COLLECTION AND
14 DISBURSEMENT UNIT (SCaDU). At any time withholding does not occur, Obligor
15 must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT
16 UNIT (SCaDU).

17 7. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances
18 (including payment in lieu of medical insurance) and spousal support balances, for
19 cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a
20 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment
21 shall accrue at the rate established by NRS 125B.140(2)(c)(1).

22 8. Pursuant to NRS 125B.095, a late fee/penalty of 10% (ten percent) of the unpaid
23 monthly child support amount will be added to the arrears balance of the Obligor if the
24 Obligor becomes delinquent in the amount owed for one month's support.

25 9. The State of Nevada has continuing exclusive jurisdiction for enforcement and
26 modification purposes pursuant to the Full Faith and Credit for Child Support Orders
27 Act.

1 It is further ordered that: Paternity established for child Amanda pursuant to default
2 acknowledgment as Obligor failed to respond to the Notice and Finding of Financial and
3 Parental Responsibility and failed to appear today. Case is arrears only as the child is not
4 currently under the care of Obligee.

5 **SUPPORT OBLIGATION BREAKDOWN AS FOLLOWS:**

6 Child Support Arrearages... **\$100.00** Effective OCTOBER 1, 2016

7 **TOTAL PAYMENT.....\$100.00**

8 Pursuant to NRS 125B.145 this Order may be reviewed every three (3) years and is subject to

11 including, but not limited to wage withholding, garnishment, liens and the attachment of
12 federal income tax returns will be undertaken upon entry of this order.
