SECOND AMENDMENT

TO

INTERLOCAL AGREEMENT TO PROVIDE WHOLESALE WATER SERVICE

(North Douglas County and Town Water Line Intertie Project)

BETWEEN

DOUGLAS COUNTY

AND

TOWN

This Second Amendment to Interlocal Agreement to Provide Wholesale Water Service ("Second Amendment") is made by and between, Douglas County ("County"), a political subdivision of the State of Nevada, and the Town of Minden ("Town"), an unincorporated town, who are at times collectively referred to herein as the "Parties" or individually as a "Party" and are public agencies pursuant to NRS 277.100.

RECITALS

WHEREAS, the County and the Town entered an Interlocal Agreement to Provide Wholesale Water Service ("Agreement"), effective January 21, 2010. The Agreement was recorded in the office of the County Recorder of Douglas County, State of Nevada on January 28, 2010, in Book 0110, at Page 5394, as Document No. 0757841, Official Records.


WHEREAS, the County and Town have entered into the First Amendment to the Agreement (the "First Amendment"); and

WHEREAS, County and Town desire to amend the Agreement by repealing the water rate schedules and establishing a new water rate schedule for Fiscal Years 2017 through 2022; and

WHEREAS, County and Town desire to work cooperatively with Carson City and the Indian Hills General Improvement District to review the existing interlocal agreements for wholesale water service and propose any necessary or desirable modifications thereto.

NOW, THEREFORE, in consideration of the promises and provisions contained in this Second Amendment, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties mutually agree as follows:

1. All prior water rate schedules are hereby superseded by the following water rate schedule for Fiscal Years 2017 through 2022:
