## CONTRACT AMENDMENT NO. 01

A CONTRACT BETWEEN

**DOUGLAS COUNTY** 

**AND** 

CARSON VALLEY RADIO, INC.

WHEREAS, Douglas County, a political subdivision of the State of Nevada ("County"), and Carson Valley Radio, Inc., a Nevada corporation ("Contractor") (hereinafter collectively referred to as "the Parties"), entered into a contract for professional services (the "Contract"); and

WHEREAS, the Parties desire to have Contractor provide additional services for the sum of \$40,000 per year; and

WHEREAS, it is deemed that the services of the Contractor herein specified are both necessary and desirable and in the best interest of Douglas County.

NOW, THEREFORE, in consideration of the agreements herein made, the Parties mutually agree to amend Articles 4 and 5 of the Agreement as follows:

4. SERVICES TO BE PERFORMED. The Parties agree that the Contractor will perform the following:

Provide monthly videographer services for the Douglas County Board of Commissioners meetings and provide the daily programming and operations of the Douglas County Community Access Television Channels 216 (Carson Valley) and Channel 19 (Lake Tahoe) as more fully outlined in the Scope of Work attached hereto as Exhibit "A."


5. PAYMENT FOR SERVICES. Contractor agrees to provide the services set forth in Paragraph 4, at a cost of Forty Thousand Dollars (\$40,000) per year (the "Contract Price"). The County does not agree to reimburse Contractor for travel expenses or other expenses necessary to provide the services to the County. The County shall make equal quarterly payments of Ten Thousand Dollars at the beginning of each quarter after receiving an invoice from Contractor for the services that will be provided to the County.

Effective this 1st day of January, 2017.

## EXHIBIT "A" SCOPE OF WORK

The Parties agree that the Contractor will perform the following:

Provide monthly videographer services for the Douglas County Board of Commissioners meetings as needed including the public meetings normally held in Minden, Nevada on the 1<sup>st</sup> Thursday of every month and at the Tahoe Transportation Center at Stateline, Nevada on the 3<sup>rd</sup> Thursday of every month. Videographer services will also be provided during special budget hearing meetings, and other Board of Commissioners and County Manager meetings as assigned.

Provide monthly videographer services for Douglas County Planning Commission meetings held on the 2<sup>nd</sup> Tuesday of every month.

Produce, edit and videotape the monthly "Douglas County Manager's Report."

Produce, edit, and videotape a program called "Inside Douglas County" managed by Douglas County's Public Information Officer no more than six (6) times per calendar year.

Provide the daily programming and operations of the Douglas County Community Access Television Channels 216 (Carson Valley) and Channel 19 (Lake Tahoe).

Act as the Custodian of Records for the foregoing audio and visual records for Douglas County and provide such assistance as may be required during litigation involving these records as requested by the County Manager.
