# DECLARATION OF TERMINATION OF DECLARATION OF BYLAWS INCLUDING COVENANTS, CONDITIONS AND RESTRICTIONS (WORLD WIDE VACATIONS CLUB OF DELAWARE)

## The Lodge at Kingsbury Crossing

This Declaration of Termination is executed as of December 30, 2016, by VI Acquisition IV, a Washington nonprofit corporation ("VIA" and "Successor Declarant") as successor by merger to World Wide Vacations Club of Delaware, a Delaware nonprofit corporation ("WWVC").

#### Recitals

- A. On or about November 1991, WWVC executed a Declaration of Bylaws Including Covenants, Conditions and Restrictions (World Wide Vacations Club of Delaware) (as subsequently amended, the "Declaration"). The Declaration subjected certain property, including Existing Project Interests and Approved Interests located on various Existing Projects or Approved Projects (collectively, the "Property"), to the provisions thereof pursuant to an incremental plan of development and improvement. The Property is further described in attached Exhibit A.
- B. The Declaration amended and restated for all intents and purposes that certain Membership Plan for World Wide Vacations Club of Delaware and those certain Bylaws of World Wide Vacations Club, each dated March 5, 1982.
- C. On or about May 6, 2016, Declarant and WWVC entered into an Agreement and Plan of Merger and Dissolution ("Merger Agreement"), pursuant to which WWVC merged into VIA with VIA being the surviving entity, and the properties that were part of the WWVC timeshare program (including the Property) are to be released from the Declaration.

- D. On or about September 12, 2016, WWVC executed an Amendment to the Declaration, Restrictions (World Wide Vacations Club of Delaware) (as subsequently amended, the "**Declaration**"), to add a mechanism for termination of the Declaration, which Amendment was recorded with the real property records of Douglas County, Nevada, on December 21, 2016, as Doc. No. 2016-892409.
- E. The Merger Agreement and the transactions contemplated therein have been approved by a Super-Majority of Members of WWVC in accordance with the Declaration and applicable laws, WWVC has now merged into VIA, and all requirements for termination of the Declaration have been satisfied.

#### **Termination**

Therefore, in accordance with the Merger Agreement and Section 9.3 of the Declaration (as amended by the Amendment), VIA, as successor by merger to WWVC and as Successor Declarant, hereby declares that the Declaration shall be and hereby is terminated in its entirety, and the Property shall be and hereby is released from any further encumbrance with respect to the Declaration, and the Declaration shall be of no further force or effect.


