


AMENDED JUDGMENT OF
DISMISSAL WITH PREJUDICE

28 THIS MATTER came before the Court on Defendants' Motion to
Dismiss for Failure to Prosecute (NRCP 41(e)) filed March 24,
2016. A hearing on the motion was held on June 22, 2016. Based
upon Findings of Fact and Conclusions of Law entered on July 14,
2016, and an Order dated October 6, 2016, the Court determined
the existence of good cause to dismiss Plaintiffs' actions with
prejudice. Consistent with that determination,

1 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Plaintiffs'
2 actions in these matters shall be and are hereby DISMISSED WITH
3 PREJUDICE.

6 January 21, 2014, as: (1) Document 0837108, in Book 0114, page
7 3307; (2) Document 0837095, in Book 0114, page 3247; and (3)
8 Document 0837094, in Book 0114, page 3242, Official Records of
9 the Douglas County Recorder, shall be and are hereby extinguished
10 and expunged and of no further force and effect.


