In accordance with NRS 278.473, I am notifying you of the following omissions and corrections to the above referenced map.

- The lot numbers for Lot 244 and Lot 245 are shown correctly on Sheet 2 of 18, but are transposed on Sheet 16 of 18. The correct lot numbers are sequential in a counter-clockwise direction around Cartwright Court.
- 2. The curve data for four (4) curves was omitted on Cartwright Court, shown on Sheet 16 of 18. The missing data is shown on Exhibit A, attached.
- 3. A dimension on the northerly line of Parcel B shown on Sheet 8 of 18 is shown incorrectly as South 82°59'40" East, 523.73 feet. The correct dimension is South 89°59'40" East, 591.93 feet, to match that Record of Survey in Support of a

- Boundary Line Adjustment recorded June 27, 2008 as Document No. 725936 in Book 0608, Page 7354, Official Records of Douglas County, Nevada.
- 4. A dimension on the westerly line of Lot 179, west of the line labelled North 79°58'47" West, 201.95 feet, on Sheet 14 of 18, was omitted. The omitted dimension is North 12°56'46" East, 29.91 feet.

The corrections of these errors and omissions do not change or purport to change the physical location of any monument, property line or boundary line.


