DEFINITIONS

(A) **"Security Instrument"** means this document, which is dated January 26, 2017, together with all Riders to this document.

(B) **"Borrower"** is JIM H. MARTIN, WHO ACQUIRED TITLE AS JIM J. MARTIN AND MARY B. MARTIN, HUSBAND AND WIFE, AS JOINT TENANTS WITH RIGHT OF SURVIVORSHIP. Borrower is the trustor under this Security Instrument.

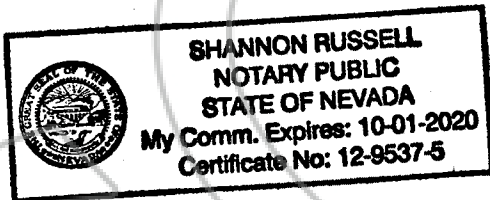
