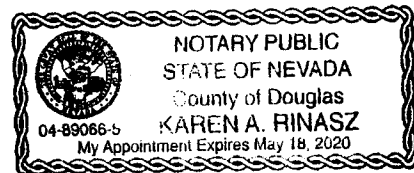


Exhibit A - LEGAL DESCRIPTION
