DEED OF TRUST WITH ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 2 day of March, 2017 between Dennis Kenyon, an unmarried man and Donna Tibbetts, a married woman as her sole and separate property, as joint tenants TRUSTOR, WESTERN TITLE COMPANY, LLC a Nevada limited liability company, hereinafter referred to as Trustee, and CMH HOMES, INC., A Tennessee Corporation as BENEFICIARY, WITNESSETH: That Trustor grants to Trustee in trust, with power of sale, that property in the County of Carson City, State of NEVADA described as:

Together with the rents, issues and profits thereof, subject, however, to the right, power and authority herein after given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.

For the purpose of securing (1) payment of the sum of \$158,704.00 with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust.




