7 Revised Statutes.





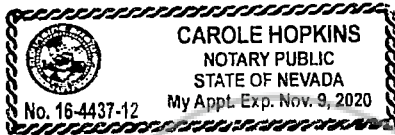
