DEFINITIONS

(A) "Security Instrument" means this document, which is dated May 27, 2017, together with all Riders to this document.

(B) "Borrower" is KATHLEEN TADICH, TRUSTEE OF THE TADICH-COWDEN FAMILY LIVING TRUST, U.T.D. 14 SEPTEMBER 2001. AS AMENDED 2 MARCH 2012, AND AS COMMUNITY PROPERTY. Borrower is the trustor under this Security Instrument.
