KNOW ALL PERSONS BY THESE PRESENTS:

THAT, BANK OF AMERICA, N.A. ("BANA"), a national banking association located at 1800 Tapo Canyon Rd., Simi Valley, CA, 93063, by these presents does hereby make, constitute and appoint Nationwide Title Clearing, Inc. ("NTC"), a Florida corporation located at 2100 ALT 19 North, Palm Harbor, FL 34683, to be BANA's true and lawful attorney-in-fact and hereby grants NTC authority and power to take, through its duly authorized officers, such Actions (as defined below) as may be appropriate, in BANA's name, place and stead. This limited power of attorney ("Limited Power of Attorney") is given in connection with that certain Statement of Work, Reference Number CW939500 and Statement of Work, Reference Number CW844305 is entered into pursuant to that certain General Services Agreement, Agreement Number CW820363 ("Agreement") having an Effective Date of May 1, 2016 between BANA and NTC, pursuant to which NTC has the duty to meet BANA's Assignment and Lien Release requirements for certain mortgage loans ("Loans"). Each of the Loans comprises a promissory note evidencing a right to payment and performance secured by a security interest or other lien on real property evidenced by one or more mortgages, deeds of trust, and deeds to secure debt or other forms of security instruments (each, a "Mortgage".

As used above, the term "Actions" shall mean and be limited to the following acts, in each case only with respect to the Loans and in accordance with state, federal and applicable law:

- 1. Execute or file assignments of mortgages or of any beneficial interest in a Mortgage;
- 2. Execute or file reconveyances, deeds of reconveyance or releases or satisfactions of mortgage or similar instruments releasing the lien of a Mortgage.


