7. The Judgment Debtor has no setoffs or counterclaims which would constitute payments or credits on the Judgment.



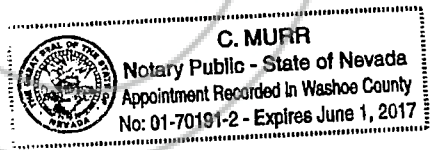
