5. The Judgment has been partially satisfied in the amount of \$7,438.92.


6. Post-Judgment interest has accrued at the legal interest rate, and the unpaid judgment balance is \$10,481.49.

8. The exact amount due on the Judgment as of May 31, 2017, is \$10,481.49.

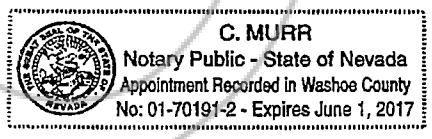


