Fairfield Tahoe at South Shore**

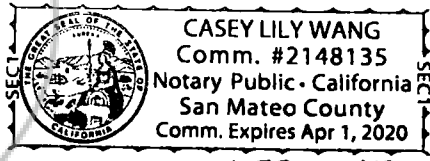

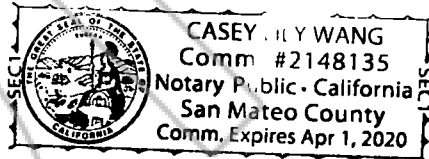

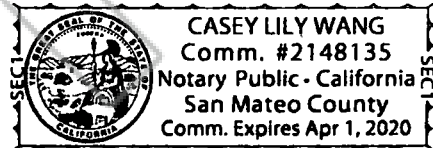
