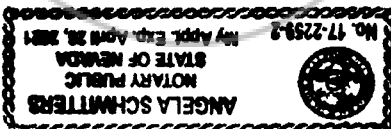

15 JUDGMENT AND ORDER

16 *The undersigned does hereby affirm this document does not contain the social security number of any*
17 *person, pursuant to NRS 239B.030.*

18 This matter was heard on AUGUST 25, 2017. The Court Master with the following persons
19 was present:

20 Obligee: Present, via telephone Interpreted by: Patricia Bisbee

21 Obligor: Not Present

24 After considering all of the evidence, the Master hereby makes the following Findings and
25 Recommendations:

26 The Obligor was properly served on May 4, 2017, with a Notice and Finding of Financial
27 and Responsibility.

28 Obligor is the father/parent of Wendy Crvstian Ellis, born February 25, 2011.

- 1 Obligor was properly served and noticed of today's hearing at his/her last known
2 address and failed to appear.
- 3 Obligor's gross monthly earnings are \$1,213.00 Pursuant to the formula prescribed
4 within NRS 125B.070, 18% of those earnings, the state calculates a support obligation
5 in the sum of \$218.00. Gross monthly income based on actual earnings.

6 THE RECOMMENDED ORDER:

- 7 1. The Obligor shall pay \$218.00 per month in ongoing support beginning
8 September 1, 2017. The obligation for Child Support continues until the child turns 18
9 years of age, or until the child turns 19 years of age if the child is enrolled in High
10 School. However, this obligation to support a child is affected by a child's ability to
11 live on their own (NRS129.080 to 129.140 – legal emancipation) or when applicable,
12 continued financial support beyond the age of majority per NRS 125B.110.
- 13 2. An arrears Judgment is entered in the amount of \$7,825.00 for
14 August 1, 2014 through August 31, 2017.
- 15 To be paid by payments of \$40.00 per month beginning September 1, 2017.

16 All payments MUST be made in the form of a money order, cashier's check or business check
17 and payable to **STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)** and sent
18 to:

22 The following information must be included with each payment:

- 23 A. Name (first, middle, last) of person responsible for paying child support.
24 B. Social Security Number of person responsible for paying child support.
25 C. Child support case number 106-62-8100B listed on each payment.
26 D. Name of custodian (first and last name of person receiving child support).

27 **PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING OF**
28 **GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE WILL**
NOT FULFILL THE OBLIGATION. NOTICE: NO CREDIT WILL BE GIVEN FOR
PAYMENTS PAID DIRECTLY TO THE OBLIGEE.

1 3. All payments shall be made by immediate income withholding. If your full obligation
2 is not met by the amount withheld by your employer, you are responsible to pay the
3 difference between your court ordered obligation and the amount withheld by your
4 employer directly to the STATE COLLECTION AND DISBURSEMENT UNIT
5 (SCaDU). If you fail to do so you will be subject to the assessment of penalties and
6 interest. You may avoid these additional costs by making your current child support
7 payments each month.

8 4. The Obligee shall provide health insurance coverage for the child when available
9 through employment or group policy under a plan that is reasonable in cost as defined
10 in NRS 125B.085 and Obligor shall pay \$20.00 per month for health insurance
11 premium (medical cash) effective September 1, 2017. Medical costs incurred for the
12 above-referenced period have not yet been determined. The State's rights to recover
13 said costs are not waived by way of this order.

14 5. Pursuant to NRS 125B.080(7), expenses for health care which are not reimbursed
15 through insurance, including expenses for medical, surgical, dental, orthodontic and
16 optical expenses, must be shared equally by both parents.

17 6. The Obligor shall keep the Division of Welfare and Supportive Services informed of
18 any change regarding current residential and/or mailing address, employment and of
19 access to health insurance coverage in **WRITING** (including health insurance policy
20 information) within 10 days of such change.

21 7. Obligor shall be responsible for ALL child support and judgment payments due.
22 Payment is to be made directly to the STATE COLLECTION AND
23 DISBURSEMENT UNIT (SCaDU). At any time withholding does not occur, Obligor
24 must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT
25 UNIT (SCaDU).

26 8. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances
27 (including payment in lieu of medical insurance) and spousal support balances, for
28 cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a

1 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment
2 shall accrue at the rate established by NRS 125B.140(2)(c)(1).

3 9. Pursuant to NRS 125B.095, a late fee/penalty of 10% (ten percent) of the unpaid
4 monthly child support amount will be added to the arrears balance of the Obligor if the
5 Obligor becomes delinquent in the amount owed for one month's support.

6 10. The State of Nevada has continuing exclusive jurisdiction for enforcement and
7 modification purposes pursuant to the Full Faith and Credit for Child Support Orders
8 Act.

15 future modifications.

16 Unless a stay of this Order is obtained from District Court, all enforcement procedures
17 including, but not limited to wage withholding, garnishment, liens and the attachment of
18 federal income tax returns will be undertaken upon entry of this order.
