SHORT FORM OPEN-END DEED OF TRUST

DEFINITIONS

Words used in multiple sections of this document are defined below. The Master Form Deed of Trust includes other defined words and rules regarding the usage of words used in this document.

- (A) **"Security Instrument"** means this document, which is dated September 21, 2017, together with all Riders to this document.
- (B) **"Borrower"** is JOHN W. STEPLINGER, AN UNMARRIED MAN. Borrower is the trustor under this Security Instrument.

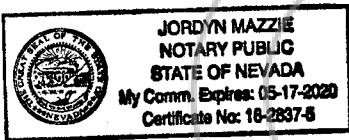
