### SHORT FORM OPEN-END DEED OF TRUST

#### DEFINITIONS

- (A) **"Security Instrument"** means this document, which is dated October 10, 2017, together with all Riders to this document.

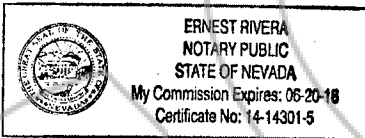


