Michelsen Family Trust dated December 2, 1975, as amended (the "Trust"), for 15 confirmation that the partnership interests of John E. Michelsen, deceased, and Ann J. 16 Michelsen, deceased, in Michelsen Kingsbury Station, a Nevada general partnership, are assets 17 of the Trust, having been considered and good cause appearing therefore, the Court finds that: 18 19 John E. Michelsen and Ann J. Michelsen, husband and wife, created The John E. 20 Michelsen Family Trust, a revocable living trust, pursuant to that certain written agreement entitled "The John E. Michelsen Family Trust Agreement" dated December 2, 1975. 21 2. John E. Michelsen and Ann J. Michelsen amended and restated certain portions of 22 The John E. Michelsen Family Trust Agreement pursuant to that certain written agreement 23 entitled "Amendment to and Restatement of The John E. Michelsen Family Trust" dated August 25 7, 2002. Collectively, The John E. Michelsen Family Trust dated December 2, 1975, as 26 amended, is referred to herein as the "Trust." 3. The Trust provides, as Section 11.1 (page 30), that it is governed by the laws of 27 28 the State of Nevada.

- 4. John E. Michelsen and Ann J. Michelsen each executed a Will on August 7, 2002, concurrently with their execution of the Amendment to and Restatement of The John E. Michelsen Family Trust. Each Will provides that all property of the decedents' estates other than jewelry, clothing, household furniture and furnishings, personal automobiles, and other tangible articles of a personal nature be transferred to the Trust upon their deaths.
- 5. Prior to December 19, 1989, John E. Michelsen and Ann J. Michelsenm husband and wife, owned all right, title and interest in that certain real property commonly known as "Kingsbury Station," located at 219 Kingsbury Grade, Stateline, Douglas County, Nevada, APN 1318-26-101-003 (the "Kingsbury Station Property"), as community property.
- 6. John E. Michelsen and Ann J. Michelsen formed Michelsen Kingsbury Station, a Nevada general partnership, and, on December 19, 1989, they executed a Quitclaim Deed by which they conveyed all their right, title and interest in the Kingsbury Station Property to Michelsen Kingsbury Station, a Nevada general partnership. The Quitclaim Deed was recorded with the Douglas County Recorder on December 19, 1989, as Document No. 216766.
- Ann J. Michelsen died on April 18, 2006, and John E. Michelsen died on July 21,
 At the time of their death, they were the sole partners of Michelsen Kingsbury Station, a
 Nevada general partnership.
- 8. Michelsen Kingsbury Station, a Nevada general partnership, is presently the owner of record title of the Kingsbury Station Property, despite that the partners are deceased.

Based on the forgoing, IT IS HEREBY ORDERED THAT:

1. All right, title and interest of John E. Michelsen, deceased, and Ann J. Michelsen, deceased, in and to Michelsen Kingsbury Station, a Nevada general partnership, are hereby confirmed to be assets of, and owned by, The John E. Michelsen Family Trust dated December 2, 1975, as amended, and are subject to management and control of the Trustees of the Trust.
