

- Notice of the time and place of the hearing has been given as required by law.; 1.
- The First and Final Account is approved in all respects; 2.

- 3. No monies are due to the State of Nevada, Department of Human Resources Medicaid Estate Recovery Unit. There are no family allowances or debts having preferences by the laws of the United States. There are no wages to third parties. There were no other sales, exchanges, investments, acquisitions, gifts, mortgages, or other transactions that increased, decreased, or otherwise altered Decedent's property holdings from those reported in the Inventory filed in this matter;
- 4. The Personal Representative and Executor has secured competent accounting advice, which reflects that no federal or state taxes are due;
- 5. That Decent ROBERT BRADLEY MICKEY dies with a Will, and the probate estate is the Decedent's separate property;

After my death, the following specific items shall be distributed to my brother, MICKEY L. COLLIER:

- All real property at 982 Bollen Circle, Gardnerville, NV 89460. a)
- All accounts in my name at Bank of America, Minden/Gardnerville b) Nevada Branch.
- All accounts in my name at Wells Fargo Bank, Minden/Gardnerville c) Nevada Branch.
- d) All accounts in my name at Navy Federal Credit Union (NFCU) Merrifield, Virginia.
- e) Amy Cars, trucks, trailers registered in my name, wherever they may be physically located.

I hereby give, devise, and bequeath the remainder of my estate, of every kind or nature and wherever situated, including property over which I have power of appointment, to my brother, MICKEY L. COLLIER, if he survives me by thirty (30) days.

- 5. MICKEY L. COLLLIER is authorized to execute a deed distributing the real property of the estate and titled personal property of the estate to himself as the sole beneficiary under the terms of the Will.
- 6. Upon proof that the fees and costs have been paid, ad upon the filing of appropriate receipts, if any, by MICKEY L. COLLIER, the Personal Representative and Executor, showing that all assets of the estate have been distributed as required, the Court shall enter an Order discharging the Personal Representative and Executor of his duties and obligations with respect to the probate estate, and shall vacate his Letters Testamentary with Will Annexed.
