AMENDED ORDER AFTER HEARING CONFIRMING SALE OF PROPERTY

This matter came before the Court on December 11, 2017 for a hearing to confirm the sale of real property. Special Guardian Helen Ann Kyles appeared telephonically, representing herself. Appearing in person was Washoe Legal Services Attorney David D. Spitzer as court-appointed attorney for the protected person, Donald George Kyles, Sr. Mr. Kyles's presence at the hearing was excused based on his medical/mental health and out-of-state residency at a care facility in Napa, California. Also present were estate agents Deborah Young and Mary Woods, and proposed buyers, Ralph Wondra and Linda Klimen-Wondra ("The Wondras").

The Court confirmed that proper notice of the proposed sale of the property had been given and that the appraised value of the property had been accurately set at \$379,000.

The property is more fully described as 2443 Meadow Circle, Genoa, Nevada high Meadows Subdivision Unit 2, Lot 54 block C, APN: 1319003-414-036. After a brief competitive bidding process, the final bidder was the Wondras who offered to purchase the property "as is" for \$400,000.00 in cash.

The Court hereby confirms the sale of the property in accordance with NRS 159.1425 and NRS 159.1435 as purchased by the Wondras under these terms.

The Guardian is authorized to execute and sign all deeds or other necessary paperwork to consummate this sale. After all costs and commissions have been paid, the guardian is required to submit to the Court an accounting of the proceeds of the sale within 60 days of the close of escrow, upon which submission and approval by the Court, this guardianship will be terminated.
