WATER RIGHTS QUITCLAIM DEED

DeCARLO, TRUSTEES of the C&R DeCARLO 1993 TRUST dated July 22, 1993, as to a 50% interest, hereinafter referred to as "Grantees".

WITNESSETH:

That said Grantor, for and in consideration of the sum of Ten Dollars (\$10.00), lawful money of the United States of America, to them in hand paid by the Grantees and for other good and valuable consideration, the receipt whereof is hereby acknowledged, have remised, released and forever quitclaimed, and by these presents to remise, release and forever quitclaim unto the Grantees and to their heirs, successors and assigns forever, all of their right, title and interest in and to the following water rights which are on file in the Nevada State Engineer's Office:

A portion of PERMIT No. 78678 being 0.32 acre-feet (.08 acres) of water annually together with pro rata rates of diversion.



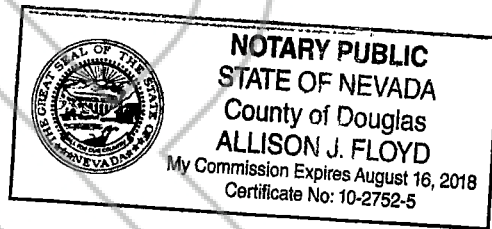
