- Obligor's gross monthly earnings are \$4,739.00. Pursuant to the formula prescribed within NRS 125B.070, 31% of those earnings, the state calculates a support obligation in the sum of \$1.469.00. Gross monthly income based on actual earnings.
- The child support amount recommended by the Court Master (set out in paragraph 1 below) deviates from the statutory percentage under NRS 125B.080, based on the following factors: pursuant to Wright vs. Osburn, the Obligee's obligation would be \$551.00 per month. Obligor given credit for one half the cost of health insurance.
- Ongoing support is ordered in the amount of \$570.00 per month beginning January 1, 2018. The obligation for Child Support continues until the child turns 18 years of age, or until the child turns 19 years of age if the child is enrolled in High School.
