

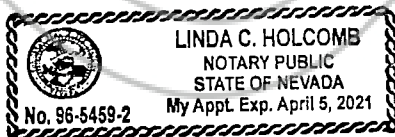

16 *The undersigned does hereby affirm this document does not contain the social security number of any*

18 This matter was heard on January 12, 2018. The Court Master with the following persons
19 was present:

21 Obligor: Not Present

23 After considering all of the evidence, the Master hereby makes the following Findings and
24 Recommendations:

25 The Obligor is the parent of the following child:

26	<u>NAME</u>	<u>DOB</u>
27	<u>OLIVER JEREMY BACON</u>	<u>AUGUST 27, 2009</u>

- 1 Obligor was properly served and noticed of today's hearing at his/her last known
2 address and failed to appear.
- 3 Obligee was properly noticed of today's hearing on or about December 14, 2017.
- 4 Obligor's gross monthly earnings are \$1,486.00. Pursuant to the formula prescribed
5 within NRS 125B.070, 18% of those earnings, the state calculates a support obligation
6 in the sum of \$267.00. Gross monthly income based on unemployment benefits.

7 RECOMMENDED ORDER IS:

8 1. Ongoing support is ordered in the amount of \$267.00 per month beginning
9 January 1, 2018. The obligation for Child Support continues until the child turns 18
10 years of age, or until the child turns 19 years of age if the child is enrolled in High
11 School. However, this obligation to support a child is affected by a child's ability to
12 live on their own (NRS129.080 to 129.140 – legal emancipation) or when applicable,
13 continued financial support beyond the age of majority per NRS125B.110.

14 2. The Obligor is responsible for **child support** arrears for the period of
15 October 1, 2017 through December 31, 2017.

16 A judgment is entered against the Obligor for **child support** arrears as follows:

17 Principal in the amount of \$4,778.59

18 Interest in the amount of \$72.92

19 Penalty in the amount of \$30.07

20 For a total judgment of \$4,881.58 to be repaid at \$50.00 per month beginning January 1, 2018.

21 3. The Obligor is responsible for **medical cash** arrears for the period of
22 October 1, 2017 through December 31, 2017.

23 A judgment is entered against the Obligor for **medical cash** arrears as follows:

24 Principal in the amount of \$60.00

25 Interest in the amount of \$0.62

26 Penalty in the amount of \$4.00

27 For a total judgment of \$64.62 to be repaid at \$10.00 per month beginning January 1, 2018.

1 All payments MUST be made in the form of a money order, cashier's check or business check

7 The following information must be included with each payment:

- 8 A. Name (first, middle, last) of person responsible for paying child support.
- 9 B. Social Security Number of person responsible for paying child support.
- 10 C. Child support case number **300-21-5200A** listed on each payment.
- 11 D. Name of custodian (first and last name of person receiving child support).

12 **PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING OF**
13 **GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE WILL**
14 **NOT FULFILL THE OBLIGATION. NOTICE: NO CREDIT WILL BE GIVEN FOR**
15 **PAYMENTS PAID DIRECTLY TO THE OBLIGEE.**

16 4. All payments shall be made by immediate income withholding. If your full obligation
17 is not met by the amount withheld by your employer, you are responsible to pay the
18 difference between your court ordered obligation and the amount withheld by your
19 employer directly to the STATE COLLECTION AND DISBURSEMENT UNIT
20 (SCaDU). If you fail to do so you will be subject to the assessment of penalties and
21 interest. You may avoid these additional costs by making your current child support
22 payments each month.

23 5. The Obligee shall provide health insurance coverage for the child when available
24 through employment or group policy under a plan that is reasonable in cost as defined in
25 NRS 125B.085 and Obligor shall pay **\$20.00** per month for health insurance premium
26 (medical cash) effective January 1, 2018. Medical costs incurred for the above-referenced
27 period have not yet been determined. The State's rights to recover said costs are not
28 waived by way of this order.

1 6. Pursuant to NRS 125B.080(7), expenses for health care which are not reimbursed
2 through insurance, including expenses for medical, surgical, dental, orthodontic and
3 optical expenses, must be shared equally by both parents.

4 7. The Obligor shall keep the Division of Welfare and Supportive Services informed of
5 any change regarding current residential and/or mailing address, employment and of
6 access to health insurance coverage in WRITING (including health insurance policy
7 information) within 10 days of such change.

8 8. Obligor shall be responsible for ALL child support and judgment payments due.
9 Payment is to be made directly to the STATE COLLECTION AND
10 DISBURSEMENT UNIT (SCaDU). At any time withholding does not occur, Obligor
11 must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT
12 UNIT (SCaDU).

13 9. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances
14 (including payment in lieu of medical insurance) and spousal support balances, for
15 cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a
16 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment
17 shall accrue at the rate established by NRS 125B.140(2)(c)(1).

18 10. Pursuant to NRS 125B.095, a late fee/penalty of 10% (ten percent) of the unpaid
19 monthly child support amount will be added to the arrears balance of the Obligor if the
20 Obligor becomes delinquent in the amount owed for one month's support.

21 11. The State of Nevada has continuing exclusive jurisdiction for enforcement and
22 modification purposes pursuant to the Full Faith and Credit for Child Support Orders
23 Act.



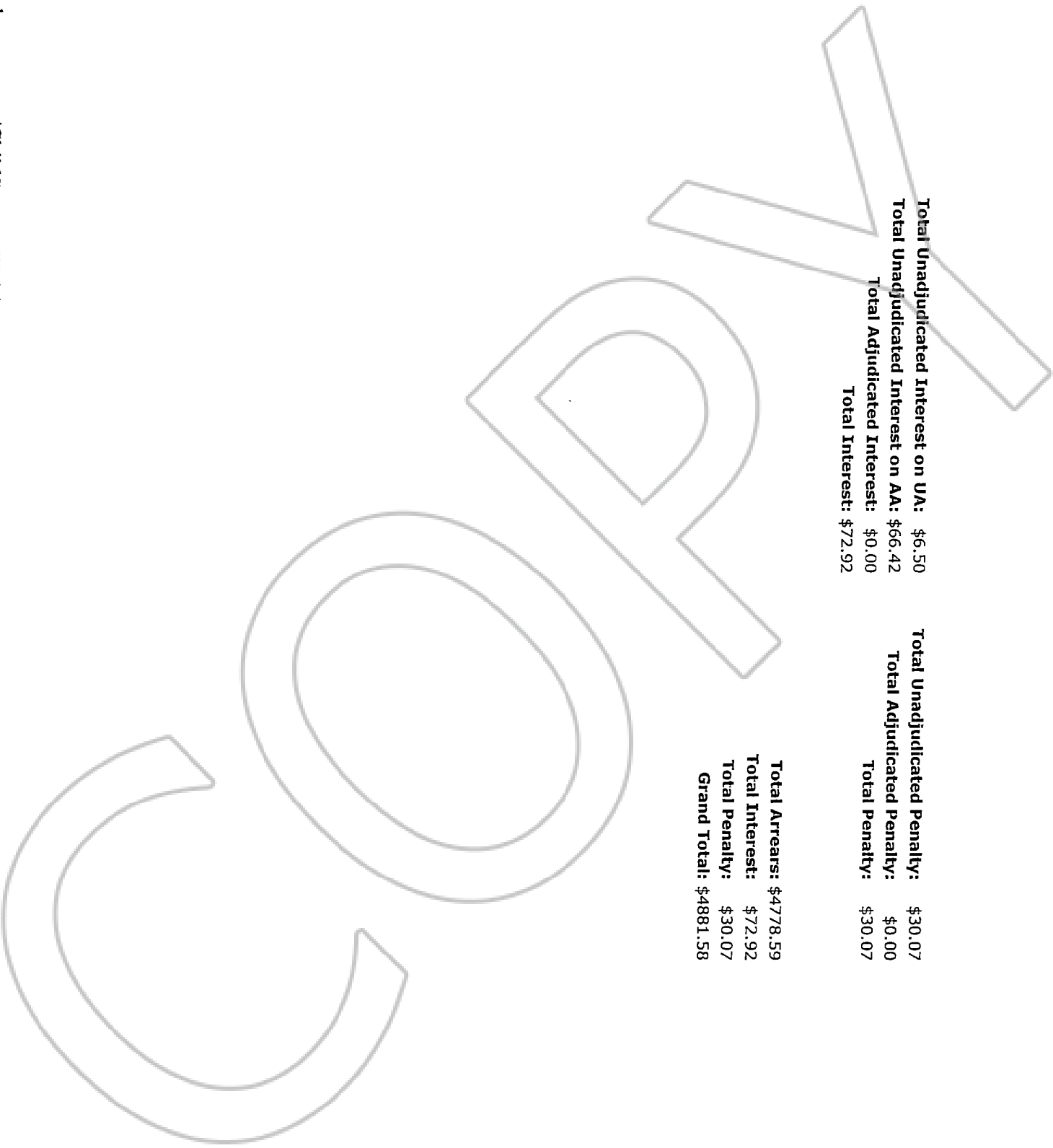
