GRANT DEED

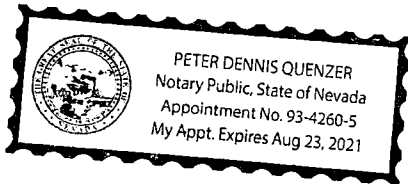
