**DEFINITIONS**

(A) "Security Instrument" means this document, which is dated February 27, 2018, together with all Riders to this document.

(B) "Borrower" is CLARK G. LESLIE AND MARJORIE S. LESLIE, HUSBAND AND WIFE, AS JOINT TENANTS WITH RIGHTS OF SURVIVORSHIP. Borrower is the trustor under this Security Instrument.

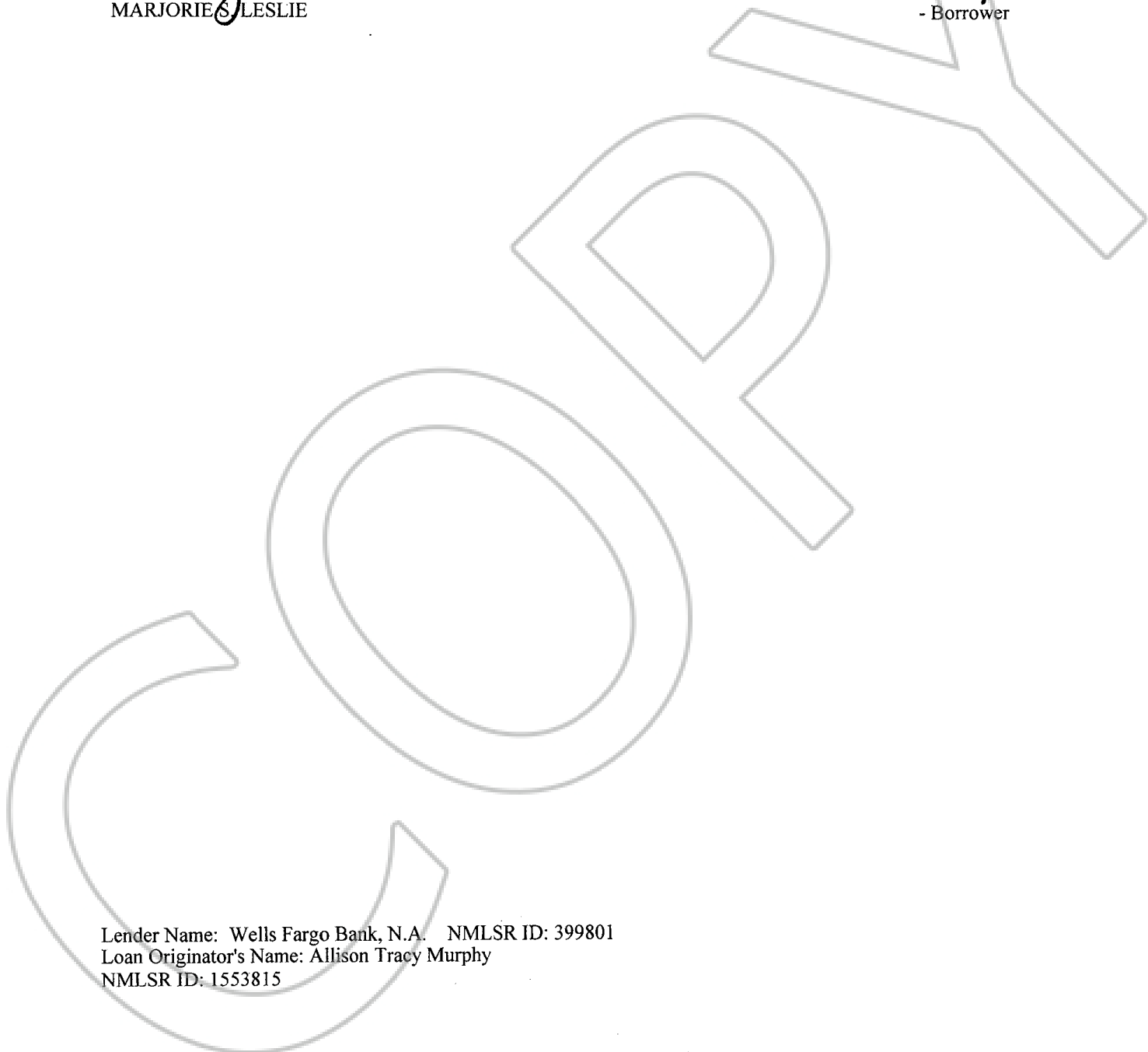

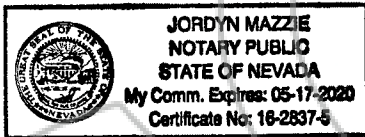


