Summer Trejo, being first duly sworn, deposes and says, pursuant to the provisions of NRS 17.214, that she has personal knowledge of and is competent to testify to the following facts:

- I am a Vice President of Judgement Creditor, LSREF2 Nova Investments II, LLC 1. ("LSREF2"). LSREF2 is the successor-in-interest to the original judgment creditor Wells Fargo, N.A., as evidenced by that Assignment of Judgment recorded in the Official Records of Washoe County as Document Number 4449748 on March 24, 2015.
- LSREF2 is the Judgment Creditor under the Foreign Judgment in Case No. 1:10cv674 (the "Judgment"), filed in the United States District Court for the Middle District of

North Carolina on January 18, 2012 as ECF No. 24. The names of the Judgment Debtors are Michael P. Taylor and Marlene Taylor. Pursuant to the Judgment, the Judgment Debtors were ordered to pay Judgment Creditor the principal sum of \$3,306,649.04, plus interest at the legal rate from the date of the judgment until satisfied and costs of the action.

- 3. On March 7, 2012, the Judgment was entered in Washoe County (Errata filed March 8, 2012) by this Court pursuant to NRS 17.350. On March 23, 2012, the Judgment was recorded in Douglas County as Document Number 799318 and an Errata to the Judgment was recorded as Document Number 799319.
- 4. On or about August 31, 2012, the Washoe County Clerk issued writs of execution to the Douglas County Sheriff and Carson City Sheriff for the enforcement of the Judgment.
- 5. In October 2012, Judgment Creditor received \$1,131.31 as payment to reduce the Judgement.
- 6. In November and December of 2012, the real property owned by the Judgment Debtors' limited liability companies was sold in accordance with North Carolina law for approximately \$2,500,000, with the total disbursements to the Judgment Creditor being \$2,440,142.04, and applied to reduce the Judgment.
- 7. On March 25, 2013, the Court issued its Order Denying Judgment Debtors' Motion to Stay Enforcement of Foreign Judgment.
 - 8. There are no setoffs or counterclaims in favor of the Judgment Debtor.
- 9. As of February 23, 2018, the exact amount due on the Judgment is \$868,802.55, plus interest accrued in the amount of \$4,922.42, and costs, for a total amount due, owing, and unpaid upon the Judgment of \$873,724.97.
