

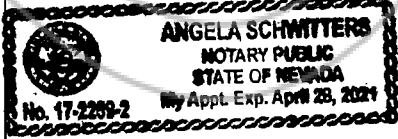

22 After considering all of the evidence, the Master hereby makes the following Findings and

23 Recommendations:

24 The Obligor is the parent of the following children:

1  Obligor's gross monthly earnings are \$0.00. Pursuant to the formula prescribed within  
2 NRS 125B.070, 25% of those earnings, the state calculates a support obligation in the  
3 sum of \$200.00. Gross monthly income based on no documented earnings.

4  The child support amount recommended by the Court Master (set out in paragraph 1  
5 below) deviates from the statutory percentage under NRS 125B.080, based on the  
6 following factors: State statutory minimum applies.

7 RECOMMENDED ORDER IS:

8 1.  Ongoing support is ordered in the amount of \$200.00 per month beginning  
9 February 1, 2018. The obligation for Child Support continues until the child turns 18  
10 years of age, or until the child turns 19 years of age if the child is enrolled in High  
11 School. However, this obligation to support a child is affected by a child's ability to  
12 live on their own (NRS129.080 to 129.140 – legal emancipation) or when applicable,  
13 continued financial support beyond the age of majority per NRS125B.110.

14 2.  The Obligor is responsible for **child support** arrears for the period of  
15 March 1, 2009 through January 1, 2018.

16  A judgment is entered against the Obligor for **child support** arrears as follows:

17  Principal in the amount of \$8,691.40

18  Interest in the amount of \$0.00

19  Penalty in the amount of \$0.00

20 For a total judgment of \$8,691.40 to be repaid at \$50.00 per month beginning February 1, 2018.

21 All payments MUST be made in the form of a money order, cashier's check or business check  
22 and payable to **STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)** and sent  
23 to:

24 **STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)**

27 The following information must be included with each payment:

28 A. Name (first, middle, last) of person responsible for paying child support.

B. Social Security Number of person responsible for paying child support.

1 C. Child support case number 876-64-1000B listed on each payment.

2 D. Name of custodian (first and last name of person receiving child support).

3 **PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING OF**  
4 **GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE WILL**  
5 **NOT FULFILL THE OBLIGATION. NOTICE: NO CREDIT WILL BE GIVEN FOR**  
6 **PAYMENTS PAID DIRECTLY TO THE OBLIGEE.**

7 3. All payments shall be made by immediate income withholding. If your full obligation  
8 is not met by the amount withheld by your employer, you are responsible to pay the  
9 difference between your court ordered obligation and the amount withheld by your  
10 employer directly to the STATE COLLECTION AND DISBURSEMENT UNIT  
11 (SCaDU). If you fail to do so you will be subject to the assessment of penalties and  
12 interest. You may avoid these additional costs by making your current child support  
13 payments each month.

14 4.  The Obligee shall provide health insurance coverage for the children when available  
15 through employment or group policy under a plan that is reasonable in cost as defined in  
16 NRS 125B.085 and Obligor shall pay \$0.00 per month for health insurance premium  
17 (medical cash) effective February 1, 2018. Medical costs incurred for the above-  
18 referenced period have not yet been determined. The State's rights to recover said costs  
19 are not waived by way of this order.

20 5.  Pursuant to NRS 125B.080(7), Obligor is responsible for one half of all expenses  
21 for health care which are not reimbursed through insurance, including expenses for  
22 medical, surgical, dental, orthodontic and optical expenses.

23 6. The Obligor shall keep the Division of Welfare and Supportive Services informed of  
24 any change regarding current residential and/or mailing address, employment and of  
25 access to health insurance coverage in WRITING (including health insurance policy  
26 information) within 10 days of such change.

27 7. Obligor shall be responsible for ALL child support and judgment payments due.  
28 Payment is to be made directly to the STATE COLLECTION AND

1 DISBURSEMENT UNIT (SCaDU). At any time withholding does not occur, Obligor  
2 must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT  
3 UNIT (SCaDU).

- 4 8. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances  
5 (including payment in lieu of medical insurance) and spousal support balances, for  
6 cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a  
7 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment  
8 shall accrue at the rate established by NRS 125B.140(2)(c)(1).
- 9 9. Pursuant to NRS 125B.095, a late fee/penalty of 10% (ten percent) of the unpaid  
10 monthly child support amount will be added to the arrears balance of the Obligor if the  
11 Obligor becomes delinquent in the amount owed for one month's support.
- 12 10. The State of Nevada has continuing exclusive jurisdiction for enforcement and  
13 modification purposes pursuant to the Full Faith and Credit for Child Support Orders  
14 Act.

15 It is further ordered that: See page 2, lines 4-6.


