WHEREAS, Owner has executed, or is about to execute, a deed of trust and note not to exceed \$ 120,000.00 dated 3/12/2018 in favor of Broker Solutions Inc DBA New American Funding, hereinafter referred to as "Lender", payable with interest and upon the terms and conditions described therein, which deed of trust will record concurrently herewith on 03/19/2018, in Book n/a, Official Records, Page n/a, as Document No. 2018-911725; and

WHEREAS, it is a condition precedent to obtaining said loan from lender that said deed of trust last above mentioned shall unconditionally be and remain at all times a lien or charge upon the land hereinbefore described, prior and superior to the lien or charge of the deed of trust first above mentioned; and
