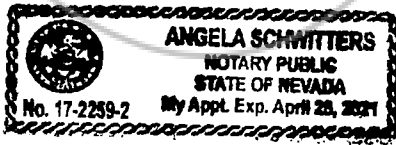

After considering all of the evidence, the Master hereby makes the following Findings and Recommendations:

The Obligor was properly served on September 13, 2017, with a Notice and Finding of Financial and Responsibility.

Obligor is the mother/parent of Journey Taneal Faith George, born November 25, 2010.

1 THE RECOMMENDED ORDER:

2 1.  An arrears Judgment is entered in the amount of **\$3,379.00** for  
3 May 1, 2016 through November 30, 2017.

4  To be paid by payments of **\$50.00** per month beginning December 1, 2017.

5 All payments MUST be made in the form of a money order, cashier's check or business check  
6 and payable to **STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)** and sent  
7 to:

8 **STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)**  
9 **P.O. BOX 98950**  
10 **LAS VEGAS, NV 89193-89501**

11 The following information must be included with each payment:

- 12 A. Name (first, middle, last) of person responsible for paying child support.
- 13 B. Social Security Number of person responsible for paying child support.
- 14 C. Child support case number 777-65-8000A listed on each payment.
- 15 D. Name of custodian (first and last name of person receiving child support).

16 **PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING OF**  
17 **GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE WILL**  
18 **NOT FULFILL THE OBLIGATION. NOTICE: NO CREDIT WILL BE GIVEN FOR**  
19 **PAYMENTS PAID DIRECTLY TO THE OBLIGEE.**

20 2. All payments shall be made by immediate income withholding. If your full obligation  
21 is not met by the amount withheld by your employer, you are responsible to pay the  
22 difference between your court ordered obligation and the amount withheld by your  
23 employer directly to the STATE COLLECTION AND DISBURSEMENT UNIT  
24 (SCaDU). If you fail to do so you will be subject to the assessment of penalties and  
25 interest. You may avoid these additional costs by making your current child support  
26 payments each month.

27 3. The Obligor shall keep the Division of Welfare and Supportive Services informed of  
28 any change regarding current residential and/or mailing address, employment and of  
access to health insurance coverage in **WRITING** (including health insurance policy  
information) within 10 days of such change.

- 1 4. Obligor shall be responsible for ALL child support and judgment payments due.  
2 Payment is to be made directly to the STATE COLLECTION AND  
3 DISBURSEMENT UNIT (SCaDU). At any time withholding does not occur, Obligor  
4 must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT  
5 UNIT (SCaDU).
- 6 5. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances  
7 (including payment in lieu of medical insurance) and spousal support balances, for  
8 cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a  
9 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment  
10 shall accrue at the rate established by NRS 125B.140(2)(c)(1).
- 11 6. Pursuant to NRS 125B.095, a late fee/penalty of 10% (ten percent) of the unpaid  
12 monthly child support amount will be added to the arrears balance of the Obligor if the  
13 Obligor becomes delinquent in the amount owed for one month's support.
- 14 7. The State of Nevada has continuing exclusive jurisdiction for enforcement and  
15 modification purposes pursuant to the Full Faith and Credit for Child Support Orders  
16 Act.

17 It is further ordered that: Case is arrears only as the child currently resides with the Obligor.


