TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

Whereas, Charles Weather of Lyon County, Nevada has deposited with the Register of the State Land Office at Carson City the State Treasurer's receipt, whereby it appears that full payment has been made by the said Charles Weather according to the provisions of the Act of the Legislature, approved March 5, 1873, entitled "An Act to provide for the selection and sale of lands that have been or may hereafter be granted by the United States to the State of Nevada. And the Acts amendatory thereof and supplementary thereto."

For the South west quarter of the South west quarter of Section Twenty one (21), Township Thirteen (13) North, Range Twenty two (22) East,

Monte Diablo, base and meridian, containing Forty acres, according to the official plot of the survey of the Public Lands as made by the United States Surveyor General for the District of Nevada; which said tract has been purchased by the said Charles Weather

Therefore, know ye, That the State of Nevada, in consideration of the premises, and in conformity with the Act of the Legislature in such case made and provided, has given and granted, and by these presents does give and grant unto the said Charles Weather and to his heirs, the said tract above described,

To Have and to Hold the same, together with all rights, privileges, immunities and appurtenances, of whatsoever nature, thereunto belonging, unto the said Charles Weather and to his heirs and assigns forever.
