Termination of Easement by Occurrence of Condition

WHEREAS, on July 11 , 2014, Tahoe Shores, LLC, a Nevada limited liability company ("TS"), granted Kingsbury General Improvement District, a Nevada political subdivision ("District"), a permanent 10-foot wide public utility easement ("Permanent PUE") in Assessor's Parcel Number (APN) 1318-22-002-001 and a conditional 10-foot wide public utility easement ("Conditional PUE") in 1318-22-002-002, which easements were recorded on September 25 , 2015, as Document No. 2015-870139 in the Official Records of Douglas County, Nevada.

WHEREAS, the purpose of both the Permanent PUE and the Conditional PUE was for the District to locate, operate, reconstruct, repair and maintain a raw water pipeline.

WHEREAS, on March 30th, 201 5 District secured a permanent easement from UN through APN 1318-22-002-105 for the purpose of locating, operating, reconstructing, repairing and maintaining a raw water pipeline ("UN Easement").

NOW THEREFORE, this Termination of Easement by Occurrence of Condition hereby evidences the termination of the Conditional PUE that automatically occurred upon the District's securing the UN Easement, or the Condition. The Permanent PUE is unaffected by the occurrence of the Condition or this Termination.
