I. FINDINGS OF FACT

Account 4442

1. On or about February 9, 2006, Defendant Warren W. Hedstrom executed a Business Direct Credit Application—Agreement and Personal Guarantee for a Visa Wells Fargo Business Card Account 4442 (“Account 4442”).

2. The Defendants borrowed on Account 4442 and incurred a balance of \$15,923.98, which balance remains unpaid.

Account 7131

3. On or about October 10, 2005, Defendants applied for a BusinessLine Account with Plaintiff for Account 7131.

4. The Defendants borrowed against the Account 7131 Business Line Account incurring an unpaid balance of \$48,542.25.

II. CONCLUSIONS OF LAW

Pursuant to N.R.C.P. 56(c) the Court makes the following legal determinations:

As required by N.R.C.P. 56(e), the Plaintiff’s Motion was properly made and supported with an affidavit and evidence proving that Plaintiff is entitled to judgment against the Defendants for the unpaid principal balance of \$64,466.23 on credit received on accounts 4442 and 7131, plus interest plus attorney’s fees and costs.

The Defendant did not file any timely written opposition as required by N.R.C.P. 56(e) and Ninth Judicial District Court Rule 6 and District Court Rule 13.3 (King v. Cartlidge, 121 Nev. 926 (2005) (“If the opposing party fails to serve and file an opposition [to a motion for summary judgment], the district court has the discretion to construe that failure as an admission that the motion is meritorious an a consent to granting the motion.”))

**JUDGMENT**


