DEFINITIONS

Words used in multiple sections of this document are defined below. The Master Form Deed of Trust includes other defined words and rules regarding the usage of words used in this document.

(A) "Security Instrument" means this document, which is dated June 05, 2018, together with all Riders to this document.

(B) "Borrower" is ERIC KLESITZ, TRUSTEE OR HIS SUCCESSORS IN TRUST UNDER THE KLESITZ LIVING TRUST DATED MARCH 22, 2007. Borrower is the trustor under this Security Instrument.

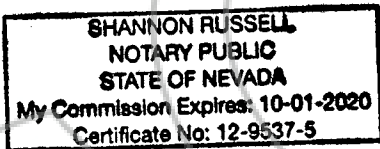


