## GRANT DEED

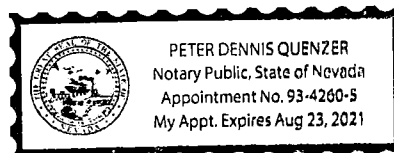
