

- 8. All of John Voss' right, title and interest in Hangar A-13 located at the Minden-Tahoe Airport is an asset of the Trust to be held, administered, and distributed by Joseph Martin Voss, as successor trustee, under the terms of said Trust.
- 9. John Martin Voss is survived by his adult children, four sons, Joseph M. Voss, John T. Ravize, Robert O. Voss and Michael G. Voss. They have had notice of the proceedings and have voiced no objection to the petition on file or to the request made therein.
