THIS CAUSE, having come before the Court upon Plaintiff EBF PARTNERS, LLC's Motion to Enforce Stipulation of Settlement and for Entry of Stipulated Final Judgment, the Court, having heard argument of counsel, having reviewed the Stipulation of Settlement filed in this action, having reviewed the other pertinent papers filed herein, and being otherwise fully advised on the premises, hereby:

1. Plaintiff EBF PARTNERS, LLC, 2001 NW 107th Avenue, 3rd Floor, Miami, Florida 33172, shall have and recover from Defendants ELEVEN PUBLISHING, LLC, 180 Taylor Creek Road, Gardnerville, Nevada 89460 and/or 8593 Verde Park Circle, Las Vegas, NV 89129 and JAMES KYLE BELL, 1329 Highway 395 N., Suite 10-185, Gardnerville, Nevada 89410 and/or 8593 Verde Park Circle, Las Vegas, NV 89129, Social Security No. jointly and severally, the sum of \$88,109.84 (EIGHTY-EIGHT THOUSAND ONE HUNDRED NINE AND 84/100 DOLLARS), which sum shall bear pre-judgment interest at the statutory interest rate of 4.75% from August 10, 2015 through March 31, 2016, the statutory interest rate of 4.84% from July 1, 2016 through September 30, 2016, the statutory rate of 4.91% October 1, 2016 through December 31, 2016, the statutory interest rate of 4.97% from January 1, 2017 through March 31,
