8. The exact amount due on the Judgment as of August 30, 2018, is \$24,564.03.

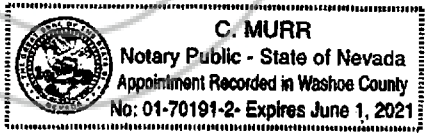
