JUDGMENT FOR ATTORNEYS' FEES AND COSTS

This cause having come before the Court on October 26, 2017, at 9:00 a.m. on Plaintiff's Motion for Attorneys' Fees and Costs against Defendants, ELEVEN PUBLISHING, LLC and JAMES KYLE BELL, ("Defendants"), the Defendants after being provided notice failed to appear at the hearing, the Court having reviewed the file, and the Court being otherwise fully informed of the premises:

IT IS HEREBY ORDERED AND ADJUDGED:

- 1. Plaintiff's Motion for Attorneys' Fees and Costs is hereby GRANTED.
- 2. Based on the evidence presented this Court finds that a reasonable number of hours to handle a matter of this type would be 24.2 hours for attorneys and 5.0 hours for paralegals; reasonable hourly rates to be charged in this matter would be \$125.00 for attorneys, and \$90.00 for paralegals.
- 3. The Court finds that counsel for Plaintiff reasonably expended \$1,415.00 in recoverable costs as set forth in the invoices for taxable costs.
- Based upon the foregoing, the Court awards a total of \$3,475.00 in attorneys' fees and \$1,415.00 in recoverable costs, for a total amount of \$4,890.00 in favor of Plaintiff, EBF PARTNERS, LLC, whose address is 2001 NW 107th Avenue, 3rd Floor, Miami, Florida 33172, against Defendants, ELEVEN PUBLISHING, LLC and JAMES KYLE BELL (Social Security No. XXX-XX-9628), whose addresses are 8593 Verde Park Circle, Las Vegas, NV 89129, which shall bear interest at the statutory rate of 5.35% per year from this date through December 31st of this



current year, for which let execution issue. Thereafter, on January 1st of each succeeding year until the judgment is paid, the interest rate will adjust in accordance with Section 55.03, Florida Statutes.

IT IS FURTHER ORDERED AND ADJUDGED that the Defendants, as judgment debtors, shall complete under oath Florida Rule of Civil Procedure Form 1.977 (Fact Information Sheet), and include all required attachments, and serve it on the Plaintiff's attorney, within 45 days from the date of this Judgment for Attorney's Fees and Costs, unless the Judgment for Attorney's Fees and Costs is satisfied or post-judgment discovery is stayed.

This Court reserves jurisdiction for the entry of further orders that are proper to compel the Defendants, as judgment debtors, to complete Form 1.977 including all required attachments, and serve it on the judgment creditor's attorney, and for the assessment of additional attorneys' fees and costs that may be incurred by Plaintiff in its efforts to collect this Judgment.
