### RECITALS

WHEREAS, Assignor, as lessor, and PTP, INC., as lessee, entered into that certain Master Lease Agreement dated October 8, 1997 and recorded in the real estate records of Douglas County, Nevada at Book 1097, page 2349 as Document Number 0423882 (the "Lease") for the lease of certain real property located in Douglas County, Nevada as more particularly described in the Lease (collectively, the "Property");

WHEREAS, PTP subsequently divided the Property into 228 lots and developed it into a residential subdivision known as the Pine View Estates;

WHEREAS, the Lease provided for subleases of the aforementioned individual lots;

WHEREAS, Assignor commenced an action on February 26, 2015, in the United States District Court for the District of Nevada (the "Court") against PTP, the HOA, and certain of the Assignees, entitled *Leon Mark Kizer, Plaintiff v.
