ASSIGNMENT AND ASSUMPTION OF LEASE AGREEMENT

THIS ASSIGNMENT AND ASSUMPTION OF LEASE AGREEMENT (this “Agreement”) is made as of _____, 2018, by and between LEON MARK KIZER (the “Assignor”) and the persons and entities set forth on Exhibit K of the Settlement Agreement as defined below (individually an “Assignee” and collectively, the “Assignees”) (collectively, the Assignees and Assignor shall be referred to as the “Parties”).

RECITALS

WHEREAS, Assignor, as lessor, and PTP, INC., as lessee, entered into that certain Master Lease Agreement dated October 8, 1997 and recorded in the real estate records of Douglas County, Nevada at Book 1097, page 2349 as Document Number 0423882 (the “Lease”) for the lease of certain real property located in Douglas County, Nevada as more particularly described in the Lease (collectively, the “Property”);

WHEREAS, PTP subsequently divided the Property into 228 lots and developed it into a residential subdivision known as the Pine View Estates;

WHEREAS, the Lease provided for subleases of the aforementioned individual lots;

WHEREAS, Assignor commenced an action on February 26, 2015, in the United States District Court for the District of Nevada (the “Court”) against PTP, the HOA, and certain of the Assignees, entitled *Leon Mark Kizer, Plaintiff v. PTP, Inc., et al., Defendants* and captioned Case No. 3:15-cv-00120-RCJ-WGC (the “Civil Action”).

WHEREAS, certain of the Assignees answered the complaint filed by the Assignor, asserted affirmative defenses, and/or filed counterclaims against the Assignor;

WHEREAS, the Parties have reached a final complete settlement of all matters alleged in the Civil Action on the terms and conditions set forth in a settlement agreement dated September 2017 (the “Settlement Agreement”);

WHEREAS, as part of the Settlement Agreement, Assignor desires to assign to each Assignee all of his right, title and interest in the Lease (as amended from time to time) with respect to the portion of the Property that each Assignee is receiving fee simple title, as described in Exhibit H of the Settlement Agreement, pursuant to Quitclaim Deeds (as defined in the Settlement Agreement) in accordance with the Settlement Agreement, and, subject to the terms of the Settlement Agreement, each Assignee desires to assume the obligations of Assignor under the Lease with respect to the portion of the Property that each Assignee is receiving fee simple title to pursuant to Quitclaim Deeds in accordance with the Settlement Agreement.

NOW, THEREFORE, in consideration of the agreements contained herein and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

AGREEMENT

1. Assignment and Assumption of Lease. Effective as of the Trigger Date (as defined in the Settlement Agreement) with respect to Assignor and each Assignee that has executed this Assignment, Assignor hereby assigns, sells, transfers and conveys to each Assignee all of Assignor's right, title and interest in and to the Lease with respect to the portion of the Property that such Assignee is receiving fee simple title, as described in Exhibit H of the Settlement Agreement, pursuant to Quitclaim Deeds as set forth in the Settlement Agreement, and each such Assignee hereby accepts said assignment, sale, transfer and conveyance of the Lease with respect to the portion of the Property that such Assignee is receiving fee simple title to pursuant to Quitclaim Deeds as set forth in the Settlement Agreement. This Agreement is valid and fully enforceable with respect to each Assignee at the time that Assignor and such Assignee have executed this Assignment regardless of whether or not any other Assignee has executed this Assignment.

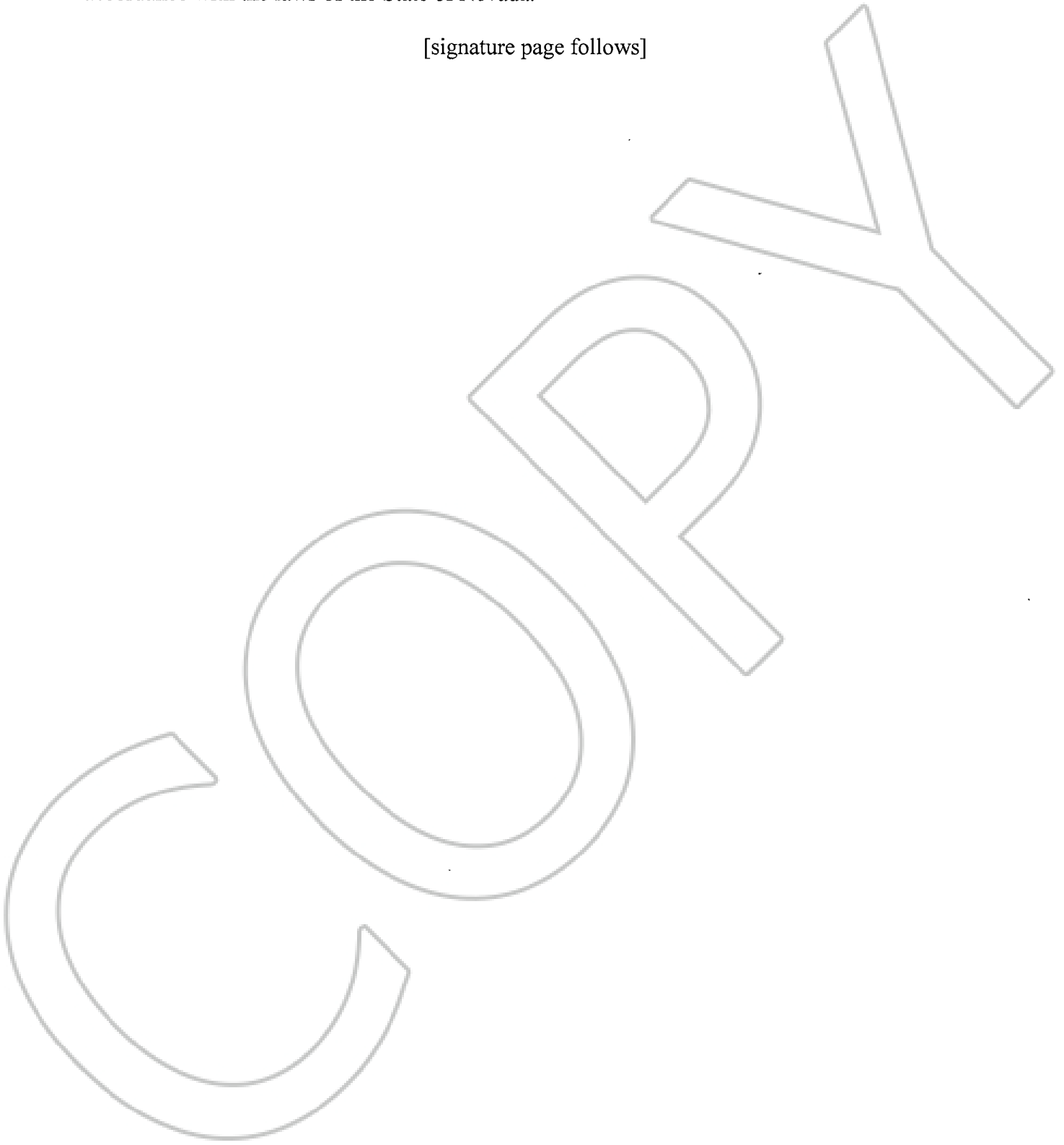
2. Continuation of Liens and Security Interest. The owners on Exhibit K of the Settlement Agreement (the "Exhibit Owners"), the Property Trustee on behalf of the Trust, and Kizer agree and acknowledge that the conveyance of lots within the Property (each a "Lot" and collectively "Lots") by the Quitclaim Deeds to the Exhibit Owners and the transfer of the Master Lease pursuant to the Lease Assignment shall not result in a merger of the Exhibit Owners' respective leasehold interests with the fee simple interests in Lots conveyed by the Quitclaim Deeds or otherwise terminate such leasehold interests. Each Exhibit Owner agrees and acknowledges that any lien or encumbrance that it has granted shall continue in full force and effect and shall remain a valid lien on such Exhibit Owner's leasehold interest in such Exhibit Owner's Lot within the Property. Each Exhibit Owner further agrees that such lien or encumbrance shall also attach to the fee simple interest in a Lot granted to the Exhibit Owner by the Quitclaim Deed in the same priority as such lien or encumbrance attached to the Exhibit Owner's leasehold interest. The Exhibit Owners further agree to execute such documents (including, without limitation, modification to their current mortgage or deed of trust documents) as are necessary to properly perfect their respective lenders' liens or encumbrances in the respective Lots that are conveyed to the Exhibit Owners by the Quitclaim Deeds. A merger of any Exhibit Owner's leasehold interest with its fee simple interest granted by the Quitclaim Deeds shall only occur upon agreement of such Exhibit Owner and the holder of such lien or encumbrance. Each Exhibit Owner agrees that the holder of any lien or encumbrance on its leasehold interest also shall have a lien or encumbrance on the Exhibit Owner's fee simple interest in the Exhibit Owner's Lot in accordance with the provisions of any loan documents between such parties. All defined terms in this paragraph refer to the defined terms in the Settlement Agreement.

3. Successors and Assigns. This Agreement shall bind and inure to the benefit of Assignor, each Assignee, and their respective successors and assigns.

4. Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original hereof and all of which shall be considered one and the same instrument.

5. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Nevada.
