

Obligor is the father of Elvssia Julia Iguado Jones, born October 28. 2001 and Eladio Ralph Iguado Jones, born July 4. 2007.

- Obligor was properly served and noticed of today's hearing at his/her last known address and failed to appear.
- Obligor's gross monthly earnings are \$1.701.00. Pursuant to the formula prescribed within NRS 125B.070, 25% of those earnings, the state calculates a support obligation in the sum of \$425.00. Gross monthly income based on actual earnings.
- The child support amount recommended by the Court Master (set out in paragraph 1 below) deviates from the statutory percentage under NRS 125B.080, based on the following factors: <u>Deviation allowed as the Obligor supports other children.</u>

THE RECOMMENDED ORDER:

- 1. The Obligor shall pay \$200.00 per month in ongoing support beginning

 December 1, 2018. The obligation for Child Support continues until the child turns 18 years of age, or until the child turns 19 years of age if the child is enrolled in High School.
