
(D) **"Trustee"** is First American Title Ins Co.



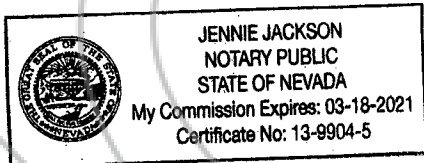
