**DEFINITIONS**

Words used in multiple sections of this document are defined below. The Master Form Deed of Trust includes other defined words and rules regarding the usage of words used in this document.

(A) "Security Instrument" means this document, which is dated February 25, 2019, together with all Riders to this document.

(B) "Borrower" is JOHN H. BORN AND KATHERINE BORN, A NON-VESTED SPOUSE, MARRIED TO EACH OTHER. Borrower is the trustor under this Security Instrument.



### MASTER FORM DEED OF TRUST



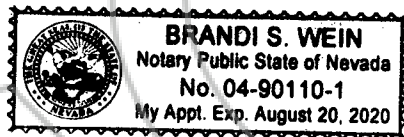
