
ABSTRACT OF JUDGMENT



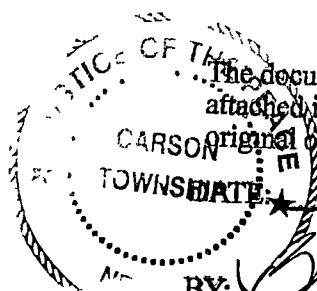
