12 matter.



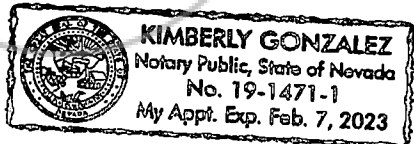


