8. The exact amount due on the Judgment as of April 30, 2019, is \$7,943.82.



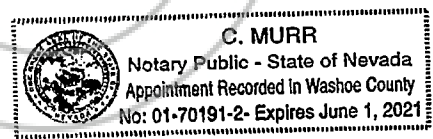



