THIS CAUSE came before the above-entitled Court on the

17 7th day of May, 2019, on a Motion and Application for

18 Approval of Attorney's Fees and Costs; Motion to Withdraw as

19 Counsel; and Motion to Appoint Sherry Lynn Newell Smith (now

20 Napier) to Serve in Proper Person as Her Own Counsel as

21

21 Guardian of the Person and Estate of the Protected Person;

23 and Motion to Appoint Counsel as Guardian Ad Litem of the

24 Protected Person, in the Discretion of the Court. After

25 reviewing all of the pleadings, documents, and records on

26 file in this case, the Court finds as follows:

1 1. On or about January 17, 2012, SHERRY LYNN NEWELL
2 SMITH (now Napier) was appointed General Guardian of the
3 Person and Estate of JAYDON RENE MARSHALL SMITH, a minor
4 Protected Person.



6 2. The law firm of GEORGE M. KEELE, A PROFESSIONAL
7 CORPORATION ("the law firm"), has rendered legal services to
8 the Guardian, including counseling with and advising the
9 Guardian on numerous legal matters pertaining to this case,
10 preparing and filing all necessary legal documents, notices,
11 and pleadings required to date in this matter, and seeking
12 to obtain the original consent to adoption of the Protected
13 Person by Sherry Lynn Newell Smith Napier. The law firm and
14 the Guardian have agreed that a reasonable fee for the
15 services rendered is \$325 per hour (as substantially
16 discounted to this date), to be paid after approval thereof
17 by this Court. The total of fees requested is \$17,180, less
18 a discount of \$6,000, resulting in a balance of \$11,180, to
19 be adjusted by the Court in his absolute discretion.

23 3. The law firm has advanced the sum of \$363.53 as
24 unpaid costs from November 23, 2010, through May 4, 2017, in
25 connection with this matter and is entitled to reimbursement
26 for the same.

1 NOW, THEREFORE, IT IS HEREBY ORDERED that attorney's
2 fees earned by the law firm, in the amount of \$8,080.00 and
3 costs advanced by the law firm, in the amount of \$363.53,
4 are approved as reasonable, and the Guardian is directed to
5 pay such fees and costs.


