






GRANT OF PUBLIC UTILITY EASEMENT

THIS INDENTURE is made this 2 day of April, 2019, between JPMorgan Chase Bank, National Association ("GRANTOR"), and DOUGLAS COUNTY, a political subdivision of the State of Nevada ("GRANTEE").
